HRCP Mission:

The goal of the Human Rights Commission of Pakistan (HRCP) is the realisation of the entire body of human rights and fundamental freedoms, as defined in international instruments and the Constitution of Pakistan, by all citizens of Pakistan as well as all persons present in the country – without any distinction or discrimination on grounds of gender, religion, race, belief, domicile, social status or disability, and particularly by those belonging to vulnerable and disadvantaged groups, such as women, children, members of minority communities, specially-abled persons, working people and victims of human rights abuse and, for that purpose to:

- To facilitate the Pakistani people's realisation of their basic human rights regardless of their belief, creed, ethnicity, domicile, gender or social status.
- To ensure due recognition of and respect for the people's right to democracy, basic freedoms, rule of law, protection against discrimination in any form, especially against women, minorities, and the working people.
- To strive for the earliest possible implementation of international human rights instruments in Pakistan and to persuade the government of Pakistan to play its due role in international human rights bodies.

Criteria for Membership:

Persons above the age of 18 years may apply for HRCP membership provided they fulfil the following criteria:

The applicant

Is nominated and seconded by persons who are valid members of the organization and know the applicant personally and have so declared in the membership application form, and have provided a brief description/background note on the applicant to justify the nomination for membership;

Subscribes to the HRCP aims and objects and signs the prescribed declaration to this effect in the membership application form;

Has a record of engagement with issues, causes or movements for the promotion and protection of human rights, democracy, rule of law and social justice at the local, regional or national and international levels;

Has not engaged in any serious human rights violation, nor has by words spoken or written expressed opinions or demonstrated a conduct repugnant to the values and principles enshrined in international human rights instruments, the fundamental rights guaranteed in the Constitution of Pakistan and the HRCP aims and objects;

Pledges to remain engaged with HRCP activities to a reasonable extent of her/his availability;

Submits her/his contact mailing address, mobile telephone and whatsapp numbers on SIM connections registered with PTA and/or email address, verified by the nominator and seconder, a copy of her/his CNIC, and a recent photograph, verified by the nominator and seconder, with the application.

NOTE:

HRCP Council reserves the right of admission to membership of the Society.

The applicant will be notified of approval/rejection of the membership application within 3 months of receipt of the application.

The Membership fee will be payable after the applicant has been notified of approval of membership.

Mode of Payment of Annual Subscription (Membership Fee):

Prospective or continuing members may pay their membership fee by sending HRCP a pay order or demand draft made payable to the Human Rights Commission of Pakistan or by transferring the amount electronically to the following account:
